RULES AND REGULATIONS

ARTICLE 1: PARTIES

1.1. E ULUSLAR ARASI FUAR TANITIM A.Ş.

19 Mayıs Caddesi Golden Plaza Kat: 4 Şişli/İstanbul, Türkiye
It shall be hereinafter referred to as (EUF).

1.2. The Party who signed this agreement and whose details are on the front part

It shall be hereinafter referred to as the (Participant).

ARTICLE 2: SUBJECT OF THE AGREEMENT

This Agreement regulates the liabilities between EUF and the Participant who will participate to the exhibition to be organized by EUF within the framework of the provisions written on the front side of the Participation Form which constitutes an integral part of this Agreement.

ARTICLE 3: LIABILITIES OF EUF

EUF is liable to assign to the Participant the exhibition area (stand) in the volume stated in the Participation Form which is an annex of this Agreement provided that the responsibilities of EUF is limited with the ones stated below.

The liabilities of EUF in the exhibition area is limited with providing general security, general cleaning of the exhibition area (The inside cleaning of stands shall belong to the Participant), general set up of the exhibition, printing catalogs for the publicity of the exhibition, distributing the same and presenting and announcing the exhibition.

It is at the discretion of EUF to accept or reject the service requests, other than the ones stated in this Agreement, of the Participant. In the event the additional service requests are accepted by EUF, the expenses related to such additional service and implementations and lease payments to be made for additional stand materials requested from the materials lists shall be paid by the Participant.

EUF has no undertaking against the Participant with regard to the commercial success of the exhibition.

EUF is entitled to take any and all measures which are deemed necessary in order to protect the general safety of the exhibition. The participant is required to follow the implementations anticipated by EUF for the integrity, security and commercial success of the exhibition.

EUF is entitled to reject the Participant in the event it is required for the safety of the exhibition even in cases where this Agreement is executed. The payment made by the Participant shall be reimbursed in kind to the Participant in case of a rejection.

ARTICLE 4: LIABILITIES OF THE PARTICIPANT

4.1 The withdrawal of its will after the execution of this Agreement to take part in the exhibition to which the Participant accepted to participate by signing the Agreement shall not prevent the Participant to pay the fees agreed under this Agreement. The Participant shall also pay the damages of EUF occurred from the termination of the Agreement.

4.2. The interior decoration of the stands shall be made by the personnel of the Participant by providing any and all materials and covering their expenses.

4.3. In the event stand materials are delivered to the Participant, the participant shall show necessary diligence to the same and shall not give any damage to the materials as well as the exhibition area. Otherwise, the participant shall be liable to cover the damages in cash and it will not be permitted to take the goods out of the exhibition area until its obligation is fully fulfilled.

4.4. The Participant is liable to obtain the approval of EUF for its stand decoration projects with regard to their dimensions and appropriateness to the general exhibition set up provided that any and all types of inspection and modification rights of EUF are reserved. The interior decoration of the stands shall be made by the personnel of the Participant by providing any and all materials and covering their expenses. EUF has no undertaking and liability with regard to the interior decorations of the stands. The Participant shall be made any and all of its presentation and publicity activities in the leased area without crossing the borders of the leased area.

4.5. The Participant shall follow the hour limitations anticipated for the exhibition area in locating its goods to the stands and evicting the same before opening and closing dates of the exhibition. Stands shall be evicted by the Participant until 12:00 noon of the day following the closing date of the exhibition. In the case the exhibition area could not be evicted within the given periods, goods and materials of the Participant can be taken out of the exhibition area by EUF without a need to give a warning. The liabilities for expenses to be made for this reason and any damages and losses arising from such shall be on the Participant.

4.6. EUF shall assign a free area to the Participant in the dimensions and conditions stated in the Participation Form and the Participant shall establish its stand on such area. The proceedings regarding the establishment of the stand or any other presentation unit in accordance with the project for which the approval of EUF is obtained at least 2 months before, its decoration and eviction of the area within the day following the closing date of the exhibition and expenses related to such proceedings shall be Participant's liability. The Participant shall be liable from any and all types of expenses, payments, punishments and damages and losses that may arise from these proceedings and it is not possible to forward any liability to EUF for the same. The damages that may be incurred in open area ground shall be borne by the Participant.

4.7. The Participant shall complete decoration activities one full day before the opening date of the exhibition or fair by making ready its goods for presentation and it shall make sure that a representative capable of providing technical and commercial information is available at the stand during the exhibition. Otherwise, EUF is entitled to dispose of the stand, make it ready for use for thirds parties and modify the stand without a need for a notice. In such case, the participant agrees and undertakes that it shall no forward no request for a decrease in the participation fee.

4.8. The Participant shall in no cases evict its stand and leave the exhibition area before the exhibition closing date.

4.9. The Participant is solely liable from the occupational accidents that may be incurred to the personnel employed by itself and the presentation of goods and services violating the existing provisions of law. In such cases, EUF has no liability. EUF is liable only in taking necessary measures for the safety of the exhibition area and the Participant shall be liable from the safety of the goods and providing insurance to the goods presented at the exhibition and their expenses.

4.10. The participant agrees and declares that it shall follow all rules and guidelines stated in the Technical Manuel sent by EUF.

4.11. The Participant shall not even partially lease or assign its rights arising from this Agreement to any third party or entity.

4.12. EUF is entitled to collect in full and cash any and all payments made to the employees of the Participant or to private/official third party individuals/entities with regard to their activities in the exhibition area for any reason without a need for a court order or a notice or warning sent to the Participant by documenting such payments.

4.13. The Participant agrees and declares that it shall comply with all rules and guidelines of the agreements made or to be made by EUF with third parties with regard to the exhibition or fair subject to this Agreement.

ARTICLE 5: AMENDMENTS

EUF is the party entitled to make modifications, amendments, corrections and explanations deemed necessary in the provisions of this Agreement in order to present and announce the exhibition provided that the rights of the Participant are protected.

ARTICLE 6: FEE

The fee stated in the Participation Document placed on the front side of this Agreement shall be paid to EUF on the signing date of this Agreement. EUF may prevent the Participant to take part in the exhibition in the event the participation fee is not fully paid or a payment undertaking is not granted.

ARTICLE 7: PAYMENT METHOD

The Participant shall pay all of its payments arising from this Agreement in Turkish Lira which shall be equivalent of the amount calculated by the Central Bank of Turkey foreign currency selling price on the actual payment date.

ARTICLE 8: RIGHT OF RETENSION OF EUF

EUF shall be liable of providing an exhibition area to the Participant in connection with the service and annexes subject to this Agreement and the Participant shall show necessary diligence to the stand materials in the event such are delivered to the Participant by not giving any damage to the materials as well as the exhibition area. Otherwise, the participant shall be liable to cover the damages caused by itself in cash and in the case the Participant failed to fulfill its obligation EUF shall use its **right of retention** on the Participant's goods by not permitting the eviction of goods out of the exhibition area.

ARTICLE 9: INSURANCE LIABILITY

EUF shall only take necessary measures related to the safety of exhibition area and the insurance liability for goods shall be on the Participant.

ARTICLE 10: FORCE MAJEURE

The contractual obligations of the parties will continue in cases where the exhibition is postponed due to circumstances beyond one's control and natural disasters (**force majeure**) or the exhibition is organized on a different area or in the event of an early closing.

ARTICLE 11: NOTICES

All notices and warnings to be made in connection with this Agreement shall be made through notary public to the addresses stated below. The parties hereby declare, accept and undertake that the addresses stated in the front part of this Agreement are their legal addresses available for service.

ARTICLE 12: JURISDICTION

All the disputes arising out of this Agreement shall be settled by the central courts and execution offices of Istanbul.
